Much has happened over the last few months affecting the work of JRJI. The most important part of this update is to relate and confirm that our weekly retreat visits to the different prisons up and down California have continued uninterrupted. In that regard, things in many ways are "back to normal" for JRJI. It has been so very gratifying to re-establish our relationships with JRJI participants by seeing them in person after almost two years of not being able to do so. Although the men are grateful that JRJI was able to continue to correspond with them through letters and an occasional phone call during the Pandemic, including sending "video Masses" into the prisons, nevertheless there is nothing like person-to-person contact with each other.

JRJI Assistant Executive Director, Bobby Garcia, wrote a beautiful reflection on the team's recent visit to Centinela State Prison:

It was October 18th, 2021, at approximately 2:30 in the afternoon, when we headed to the hotel near Centinela State Prison. I got to see the Salton Sea, which is so large that it extends from Palm Springs to the Gulf of California. I remember thinking to myself, "What happened here? It seems so lonely." I remembered that all of JRJI's trips to the different prisons seemed to end up in some desert or dry area. To keep my excitement at bay from the upcoming retreat, where many men had participated in the Footprints Program, I looked up information on the Salton Sea.

The Salton Sea had filled up with water and later dried up over the years. I read that in 1905, the Colorado River had overflowed, and the water flushed into the Salton area where the Salton Sea is located. Then, two years later, the Colorado river went back to its normal flow, and no more water filled this vast place. "What does this all mean?" I wondered to myself. As I gazed into this vast sea, I wondered, "How was God speaking to me?"

It all became clear after our retreat at Centinela the next day. When we were driving into the prison, I wondered what the reception in this yard was going to be. Like the flood that created the Salton Sea, good mentors like Ignacio Medina, Erick Fuentes, and Jesse Nava started the cascade of JRJI participants at this prison. However, the sea of participants at Centinela is much different from the Salton Sea. Whereas the Salton Sea had become stagnant and spoiled, the "Sea" of JRJI participants at Centinela was vast and alive. This can be explained because of the "inflow of water currents" from the different prisons and the "outflow of water currents" going into the outside communities through parole. There is also another flow into lower-level prisons where a "new basin" is being created.

Just as fresh water from rivers is essential for humans and our environment to survive, we continue in our healing process to provide the new life that our spirituality and newfound freedoms bring us.

Fr. Mike and the JRJI team taught us about the healing process through JRJI programs, and I witnessed how many lives were empowered that day. From tears of pain, to smiles of happiness, we all shared, learned, and supported each other. There is nothing better than to see the healing process alive and to see it move into Centinela and then out of Centinela. We cannot wait until our next retreat.
